WHAT IS LRS?

The Lawyer Referral Service (LRS) is a public service of the Alameda County Bar Association.

- For an administrative fee of \$30, the LRS will refer you to an attorney who matches your legal needs. LRS has a panel of lawyers specializing in more than 100 different areas of law.
- The referral includes up to a half-hour consultation with the attorney.
- For cases involving personal injury and workers' compensation, there is no fee for a referral and consultation with an experienced attorney.

WHY USE LRS?

All LRS panel attorneys are screened for their knowledge and experience and must provide proof of their qualifications to serve on panels.



- All LRS panel attorneys are required to carry malpractice insurance.
- All LRS panel attorneys agree to meet with clients in Alameda County.
- LRS is regulated and certified by the State Bar of California and meets the standards for lawyer referral services of the American Bar Association.

THE LRS PLACEMENT PROCESS

- **STEP 1.** Call LRS and explain your legal situation to a professional referral counselor. The counselor will collect your payment information, though you will not be charged unless we find you a referral.
- **STEP 2.** The referral counselor will call you back with your referral information in two to three days.
- **STEP 3.** You contact your attorney to schedule a consultation.
