SB 357 (Wiener): Crimes: loitering for the purpose of engaging in a prostitution offense. (Similar to Resolution 01-06-2021, by the Bar Association of San Francisco)

AB 2321 (Jones-Sawyer): Juveniles: room confinement (Similar to Resolution 07-01-2016, by the National Lawyers Guild)

SB 103 (Dodd): Uniform Faithful Presidential Electors Act (Similar to Resolution 07-04-2021, by the San Diego County Bar Association)

AB 2960: Judiciary Omnibus (Similar to Resolution 04-04-2021, by the Bar Association of Northern San Diego County)
